Mayor Curtis Hayes called the meeting to order.

Bill Linder made the motion to accept the minutes as handed out. Ken Dodson seconded the motion. The vote was 6 yes and 0 no.

Mayor Hayes presented Ordinance 2018-3-1 (An Ordinance to Amend the Zoning Ordinance by allowing residential uses as a permitted upon appeal in the I-1 (light industrial) Zoning District. This was recommended by the Livingston Planning Commission.

Bill Linder made the motion to approve the first reading on Ordinance 2018-3. Ken Dodson seconded the motion. The vote was 6 yes and 0 no.

Levi Crowder was present to discuss wakeboarding at Dillon Pond. This is the same thing that had been approved for City Lake. He stated that they would like permission to investigate if this activity could be allowed at Dillon Pond.

David Langford made the motion to approve the investigation of using Dillon Pond for wakeboarding. Ronald Dishman seconded the motion. The vote was 6 yes and 0 no.

Alderman Dishman stated that he has had requests from residents about streets needing to be paved especially on Kennedy Street, Long Street and Tennessee Drive.
