Mayor Curtis Hayes called the meeting to order.

Chris Speck made the motion to accept the minutes as handed out. Ken Dodson seconded the motion. The vote was 4 yes and 0 no.

Chris Speck made the motion to add Item #8 Steven Crook of Highlands to agenda. Kelly Coleman seconded the motion. The vote was 4 yes and 0 no.

Ray Evans gave an update on the following projects:

- 1. Sidewalk project- They have received approval from all agencies and have the final set of construction plans.
- 2. TDOT Grant: Courthouse area including sidewalks None of the stamped bricks will be removed, possibility of alternative water feature, memorial canon moved to a central location
- New TDOT Grant: This is a 100% grant with zero match. The application is due on June 10th.
 It is very limited to what can be done with this grant. Considering a pedestrian signal and a 4th signal on side that has no traffic signal.
- 4. Downtown Revitalization Committee has not be meeting due to COVID 19 but they will meet the 3rd Friday in June

Bridget Jones and Nancy Williams of TN Main Street discussed the requirements of being a part of the Main Street Program. It is a requirement of the National Program that you attend 3 trainings per year. You also need to have a paid part-time staff person for the National Program. This staff person could be

someone that was already on staff. They stated that the Main Street Program does not have any restrictions concerning changes or restrictions of existing buildings.

Sherry Jackson of the U. S. Census Bureau gave an update on the 2020 Census. She stated that the National self-response rate for 60.4%, Tennessee self-response rate 60.5 % and Livingston self-response rate was 57.4%. She stressed the importance of everyone responding to the Census and the different ways that they could respond. The population count determines the amount of federal funding for roads, schools, etc.

Ben Winningham of UCEMC stated that the lighting project is complete. From December 2019 to April 2020 there was a 21,437.84 savings due to the new lights being installed.

The Board stated that they would be looking at other areas to replace existing lights with LED lights.

Donna Holton and Marcie Ackerman gave an update on the Hazard Mitigation and what the next steps would be.

Kristian Mansell, Codes Enforcement, gave an update on properties that had been brought before the Property Maintenance Committee.

Mayor Hayes stated that the following bids had been received on a lawnmower for City Park. The bids were as follow:
