

Regular Meeting of the Livingston Mayor and Board of Alderman on May 3,2021 at Livingston City Hall at 6:00 p.m.

Mayor Curtis Hayes called the meeting to order.

Kelly Coleman made the motion to accept the minutes as handed out. John Clough seconded the motion. The vote was 5 yes and 0 no.

Rex Dale made the motion to add the following items to the agenda:

8. Livingston Airport
9. Police Department – replacement of officer

Ken Dodson seconded the motion. The vote was 5 yes and 0 no.

Ken Dodson made the motion to pass the second reading on Ordinance 2021-4-1(Parking Space Requirements). John Clough seconded the motion. The vote was 5 yes and 0 no.

Ray Evans, Downtown Revitalization Chairman, gave an update on the Courthouse Square Project, the Sidewalk Project and Façade Grant.

Shannon Cantrell discussed the mural project. The location of the second mural would be Picker's Palace #2.

Rex Dale made the motion to approve this mural. Ken Dodson seconded the motion. The vote was 5 yes and 0 no.

Amanda Mainord of Grassroots Planning and Consulting presented Resolution 2021-5-1. This resolution is to apply for a home rehab grant. This would be for residents in the city limits. They would have to own the home and meet the guidelines.

David Langford made the motion to adopt Resolution 2021-5-1. Kelly Coleman seconded the motion. The vote was 5 yes and 0 no.

Mayor Hayes presented Ordinance 2021-5-1 (rezoning properties from I-1 to C-1).

John Clough made the motion to adopt the 1st reading of Ordinance 2021-5-1. Rex Dale seconded the motion. The vote was 5 yes and 0 no.

Mayor Hayes stated that the public hearing on this would be June 7th at 5:50 p.m.

Ken Dodson made the motion to approve the final auction list for the public auction on May 22, 2021 at Noon. Kelly Coleman seconded the motion. The vote was 4 yes with David Langford voting no.

Ken Dodson made the motion to hire the following as summer workers for the pool and park: Slade Swallows, Brodey Coffee, Caeden Crane, David Sims, Luke Danner, Andrew Vaughn, Samantha Melton, Zach Kany, Matthew Savage, Emmie Crabtree, Jennifer Eilender, Bruce Lamb, Tammy Brown, Bruce Dillon, Lawrence Hawkins, Gilbert Jolley and Jackson Carson. John Clough seconded the motion. The vote was 5 yes and 0 no.

MTAS Consultant Rex Barton discussed his proposed property procedures related to cash seizures for the Livingston Police Department. He was contacted when the police department had discovered some missing funds from the evidence room.

Mayor Hayes reported that when it was discovered that funds were missing from the evidence room, the District Attorney General, Comptrollers Office and TBI was contacted. They are investigating this matter.

These procedures will be put on the June agenda so that the Board of Alderman will have a chance to review the procedures.

Jason Duke was present to discuss future plans for the airport. He also stated that Tommy Fitzgerald was terminating his T hangar lease.

Kelly Coleman made the motion to approve the termination of Tommy Fitzgerald's lease. Ken Dodson seconded the motion. The vote was 5 yes and 0 no.

Jason Duke stated that due to regulations requiring an 8 ft. fence and a 50 ft. buffer, the city would need to acquire more property. This would be covered by a 95/5 Grant. The engineering and appraisal cost would be approximately \$75,151.00.

Kelly Coleman made the motion to proceed with this project. David Langford seconded the motion. The vote was 5 yes and 0 no.

Chief Greg Etheredge recommended that Jenna Roberts be hired to replace Max Goodpasture who had resigned for medical reasons.

Mayor Hayes stated that he related to Ms. Roberts.

Ken Dodson made the motion to hire Jenna Roberts as police officer. John Clough seconded the motion. The vote was 5 yes and 0 no.

Mayor Hayes reported that the first reading on the budget would be June 7th at 5:00 p.m. and the 2nd reading on the budget would be June 28th at 5:00 p.m.

Ken Dodson made the motion to adjourn. Rex Dale seconded the motion. The vote was 5 yes and 0 no.
