

Regular meeting of the Livingston Mayor and Board of Alderman on March 7, 2022 at Livingston City Hall at 6:00 p.m.

Mayor Curtis Hayes called the meeting to order.

Rex Dale made the motion to accept the minutes as handed out. John Clough seconded the motion. The vote was 6 yes and 0 no.

Ken Dodson made the motion to accept the agenda. Rex Dale seconded the motion. The vote was 6 yes and 0 no.

Ken Dodson made the motion to pass the 2<sup>nd</sup> Reading on Ordinance 2022-2-1. Chris Speck seconded the motion. The vote was 6 yes and 0 no.

Ken Dodson made the motion to pass the 2<sup>nd</sup> Reading on Ordinance 2022-2-2. John Clough seconded the motion. The vote was 6 yes and 0 no.

Rex Dale made the motion to pass the 2<sup>nd</sup> Reading on Ordinance 2022-2-3. Kelly Coleman seconded the motion. The vote was 6 yes and 0 no.

Shannon Cantrell, Chamber of Commerce Executive Director, gave a report on the gift card program that was being started.

Alderman Dale ask if it would be possible to get a list of the participating businesses. Ms. Cantrell stated that she would get the list to them.

Representatives of TML reported that ARPA funds can now be used for infrastructure. These funds could be used for paving, green infrastructure, and storm water, etc. TDEC representatives also reported that funds are available through SRF (State Revolving Fund) with a possibility of having some of the debt being forgiven.

The city would need to have a corrective action plan and submit an infrastructural score card.

Alderman Clough ask about getting the project list that was applied for in TDEC/SRF funds and about the possibility of applying for another project if funds were available

Chris Johnson and Doug Warden of TEMA discussed thee Flood Mitigation project. Mr. Johnson stated that the Federal Government would not allow them to move forward due to the current lawsuit that has been filed and because of the lack of benefit cost analysis. They do not recommend proceeding at this point. If something changes, funding should be available because of other disasters in the state.

Board members voiced their concern that the property owners did not have clear guidelines of what was needed from day one.

Kristian Mansell gave an update on the Property Maintenance.

City Attorney had been asked about a dangerous dog ordinance. He thought that what the city had currently is sufficient since we do not have a dog pound.

City Attorney John Meadows reported that the Comptrollers Office investigation on the incident at the police department is still on going.

Kelly Coleman made the motion to adjourn. Rex Dale seconded the motion. The vote was 6 yes and 0 no.
